Why we need your information

The data on this form is being gathered for the purpose of registering you as a volunteer for the Little Ouse Headwaters Project. It is necessary to collect this information in order to contact your next of kin in the event of an accident/incident during activities, for insurance purposes, to keep you updated about volunteering activities, events and record your participation. The Little Ouse Headwaters Project will hold and handle this information in accordance with the General Data Protection Regulations 2018.

This information is being gathered and will be processed by the Little Ouse Headwaters Project and its volunteers on the basis that you are giving consent for us to do so. What we will do with your information

The information you give us will be held by the Little Ouse Headwaters Project on a secure part of the website, be password protected and only accessible to a limited number of LOHP individuals. All paper copies once inputted will be destroyed.

We will not share this information with a third party or use it for any other purpose.

How long we will keep your information

The information that you supply to us will be kept on file for six years following the date that you notify us to say that you no longer wish to volunteer or you no longer participate.

What are your rights?

Little Ouse Headwaters Project will be the Data Controller for this information. You have the following rights in relation to this data:

- You have the right to be informed about what information we hold about you and how we use it.
- You have the right to request copies of any information LOHP holds about you by making a Subject Access Request (SAR).
- If information we hold about you is factually inaccurate you have the right to have it corrected.
- You have the right to object to the way we are using your data.
- You have the right to request that your data is deleted. However, we may be
 unable to delete your data if there is a need for us to keep it. In this case you will
 receive an explanation of why we need to keep the data.
- You can also request that we stop using your data while we consider a request to have it corrected or deleted. There may be some circumstances in which we are unable to do this however we will provide an explanation if this is the case.
